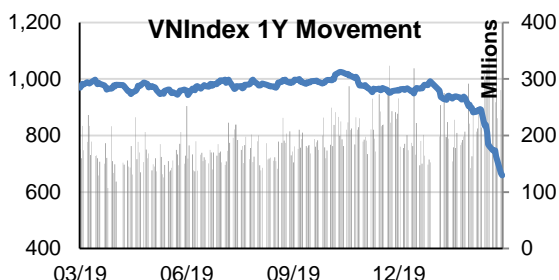

Rebound sharply

Vietnam stock markets resumed its downside due to the negative impact of the outbreak of COVID-2019 around the world. The rate of the spread is still high in the U.S. and Europe.

At the close, the VN-Index fell by 1.11% to close at 659.2 pts. Trading volume decreased to 245 million shares or VND4,030bn. The market breadth was negative with 170 decliners vs 136 advancers, showing cautious sentiment. On the Northern bourse, the HNX-Index rebounded by 0.51% to 96.9 pts as ACB and SHB, the most index distributors, surged by 1.6% and 0.8%.

Three members of Vingroup were the lagging tickers as VIC, VHM, and VRE limiting down. Besides, Seafood and Material industry underperformed the benchmark index driven by VHC (-5.8%), IDI (-1.1%), HPG (-1.2%), and HSG (-6.5%).

Moreover, few constituents of the VN30-Index dropped more than 1% such as HDB (-2.3%), MWG (-4.2%), POW (-4.3%), ROS (-7.0%), SBT (-6.9%), SSI (-3.1%), and STB (-3.5%).

In contrast, cash flowed into some large-cap stocks, namely VNM (+2.9%), VJC (+0.7%), VCB (+1.4%), REE (+1.6%), PNJ (+0.4%), BID (+2.6%), BVH (+7.0%), CTD (+2.4%), FPT (+0.2%), and GAS (+4.3%).

Foreign investors continued to sell sharply with a net value of VND661bn on HSX. MSN, HPG, and VRE were sold the most with net values of VND113bn, VND101bn, and VND82bn, respectively. On the buy side, VCB, CTG, and PHR were in the top of the list.

Market sentiment has become cautious as the high selling pressure on blue-chip tickers. That pushes downside risk high. Therefore, traders should stay on the sidelines and wait for the next bullish signal.

Breaking news

U.S. Senate finally approved a massive aid package of USD2tn to support Americans and corporates under the severe impact of COVID-19 pandemic.

After a couple of rounds of negotiations between the Democrats and the Republicans, two sides finally reached an agreement on the massive fiscal stimulus package, according to the White House official's announcement on Wednesday. The public has not been clear about what is inside the new bill when the full text of the pact is expected to be released on Thursday. However, through some reliable sources, the package is expected to include USD500bn fund to help heavily-affected firms, USD3,000 of direct payments to U.S. families, additional USD250bn for unemployment aid, USD350bn for small-business loans, and approximately USD75bn for health facilities. Insider members of MWG to increase their hold. Insider members of Mobile World Investment (HOSE: MWG) has registered to buy 1.7mn shares of MWG via orders matching and/or put-through method. The transaction is expected to be conducted from 27 Mar to 25 Apr 2020. (ndh.vn)

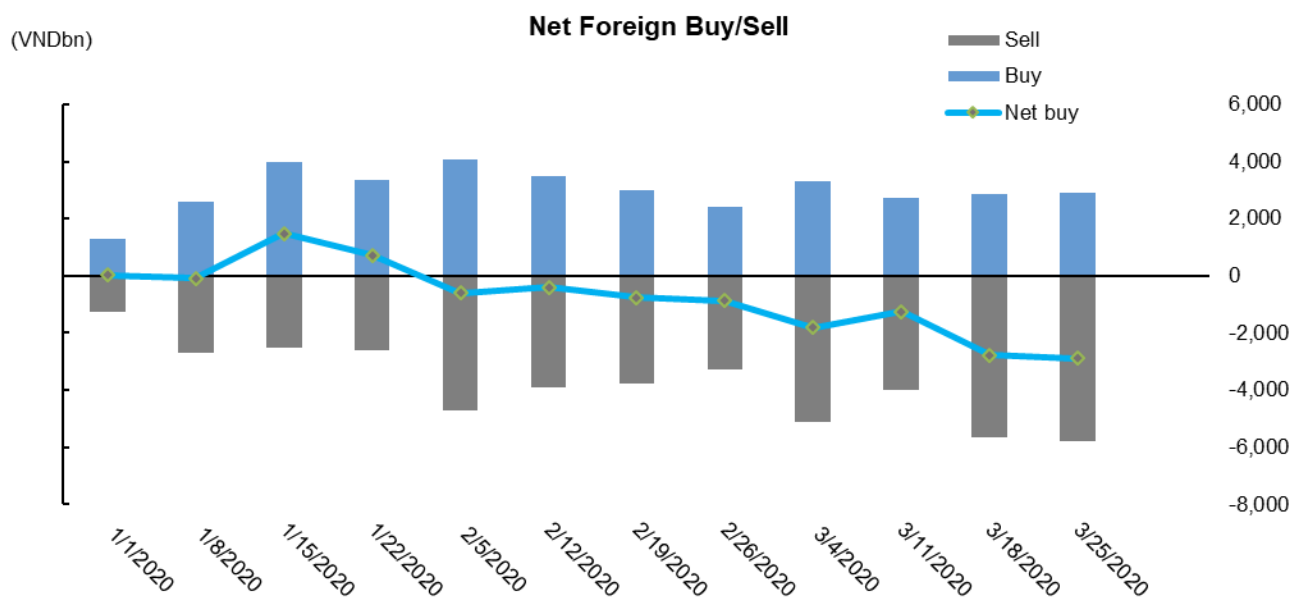
